Sales to other than the former record titleholder, his or her heirs, devisees or assigns shall be by the best means available to obtain the maximum price, and to expend such funds as the majority of the Select Board shall decide, except that the Select Board shall use the special sale process required by 36 MRSA 943-C for qualifying homestead property if sold to anyone other than the former owner(s).

**ARTICLE 25.** To see if the Town will vote to authorize the Tax Collector to accept prepayment of taxes not yet due or assessed and no interest to accrue.

**ARTICLE 26.** To see if the Town, in accordance with 36 MRSA Section 505 (4), will vote that property taxes shall be delinquent if not paid by November 15, 2023 and May 15, 2024, and that interest at the rate of 8% per annum shall be charged on all delinquent property taxes, or act thereon. If the due date(s) fall on a Saturday, Sunday, or holiday, then the due date(s) will fall on the next business day, and interest will start the day after.

**NOTE:** The Select Board recommends due dates of November 15, 2023 and May 15, 2024, and interest due dates of November 16, 2023 and May 16, 2024 and interest at the rate of 8% per annum.
